SUPPLEMENTAL NARRATIVE:

Initial Case Narrative by J. Velasco #5703 on 07/05/10 at 0238 hrs.

Total Dictation Time = 3:48 mins.

On 07/04/10 from approximately 2130 hours to 2330 hours, the Pima County Sheriff's Department (PCSD) conducted a DUI checkpoint located at Colossal Cave Road just south of Trotter Sisters Drive.

For further information as to why the PCSD decided to conduct the checkpoint at that location, please see the Operations Plan.

During the time PCSD conducted the DUI checkpoint, eight deputies took part in the checkpoint along with the PCSD Sheriff's Auxiliary Volunteers (SAVs) and two Arizona Rangers were also involved. During that time, 834 vehicles were stopped. Eight DUI investigations were conducted. Four people were arrested for DUI. Six other arrests were made, two for Liquor Laws and four for Drugs or Drug Paraphernalia. One of the DUIs was an Aggravated DUI.

The checkpoint commander was Lieutenant K. J. Woolridge #858. I was the administrative support deputy. As for the phlebotomist, a correction was made. Deputy E. C. Curtin #1154 was the phlebotomist at that time. Signs, placement and pickup were conducted by Deputy D. Gifford #1322 and Deputy B. Bernstein #5680. The setup was conducted by Deputy Curtin and Deputy J. M. Weeks #5986. Sergeant M. S. Grider #793 and Sergeant W. D. Murphy #833 were the supervisors on scene.

This concludes my involvement.
