Initial Case Narrative by D. S. Hanna #1258 on 04/16/11 at 2158 hrs.

On Friday, 04/15/11 at approximately 2000 hours, I conducted a sobriety checkpoint briefing with Pima County Sheriff's Department personnel in the Sheriff's Department Operations Center located in the Sheriff's Administration Building.

I gave a Power Point presentation to staff members that were participating in the checkpoint for this evening. Once the checkpoint briefing was conducted and briefing checklists were signed and returned, we then made our way to the location which was determined to be at Ina and Mona Lisa. Earlier that day I did go out to that location to (INAUDIBLE) the checkpoint as well as completed field sobriety tests to ensure that the location where the field sobriety tests that were going to be conducted throughout the checkpoint was a suitable location.

The checkpoint became operational at 2100 hours and concluded at 2330 hours. During that point in time, 1085 vehicles passed through the checkpoint. There were four field sobriety tests and three DUI arrests along with three other arrests which included drug possession/marijuana possession, drug paraphernalia, and a suspended driver's license. A modified vehicle screening took place during the first hour of the operation at 2100 eastbound operations, 2123 westbound operations, 2143 eastbound operations, 2200 hours both east and westbound operations for the duration of the checkpoint.

I then completed a Force Commander Summary.

NOTE: I sent out several deputies from my location at the checkpoint to assist patrol deputies with a DUI related collision and a DUI investigation in other districts.

This concludes my involvement.
