Initial Case Dictated by D. S. Hanna #1258 in Supp 1

**SUPPLEMENTAL NARRATIVE:**

Initial Case Narrative by D. S. Hanna #1258 on 02/06/10 at 2121 hrs.

Total Dictation Time = 7:52 mins.

On Friday 02/05/10 at approximately 2000 hours, I was participating with the Special Operations Sobriety Checkpoint Program. This evening's sobriety checkpoint was determined to be placed at 7700 West Picture Rocks Road. It was determined to be placed in this location due to the statistical data over the last several years and of DUI incidents occurring in this location.

This weekend's deployment was to address several functions, including the Gem Show, Superbowl Weekend as well as continued impaired driving enforcement on this particular stretch of roadway within Pima County.

Lieutenant K. J. Woolridge #858 conducted the briefing for this evening's sobriety checkpoint. He delivered a Powerpoint presentation to the staff members and volunteers working the checkpoint that I created prior to their deployment.

Once staff members were given their assignments, we then went to the location to set up the checkpoint. It should be noted that the media was notified prior to the sobriety checkpoint in fact. I specifically spoke with several reporters from various television media about the sobriety checkpoint. Due to its location, however, the ability to get a live feed due to some technical issues, they were not able to come out to the sobriety checkpoint. Additionally, besides the fact I had sent out a media release, I also placed this on Twitter to notify followers of Twitter through the Sheriff's Department that a sobriety checkpoint and DUI patrol was going to take place this weekend.

The sobriety checkpoint became operational at approximately 2100 hours and concluded at 2330 hours. There were 402 vehicles that passed through the checkpoint. Five field sobriety tests were conducted and three DUI arrests were made. Additionally, there was one additional arrest for an open container of alcohol.

I noted that of the three DUI arrests, the first subject Deputy R. Roher #5347 was out with, I spoke with him and observed the subject had eyelid tremors and body tremors. I took a quick pulse and observed 60 beats per minute for a pulse rate of 120. Although there was no alcohol on this subject, the individual was ultimately placed under arrest for DUI with the possibility of drug involvement.

The second DUI arrest occurred with Deputy D. Gifford #1322 making contact with a male subject. I observed him from the other side of the checkpoint, and I thought his cigarette was ready to fall out of the subject's mouth. He had a very long and dazed look on his face as he slowly got out of his vehicle, which

was a pickup truck and was very slow in his actions. During the field sobriety tests, though I did not observe all of them, I was able to get a portable breathalyzer test (PBT) which resulted in a positive reading of .244 blood alcohol concentration (BAC). At that point I directed Deputy R. N. Carlson #5959 who had just arrived on scene to complete a Notice of Vehicle Immobilization form as it was ultimately determined that the subject Deputy Gifford was investigating was under arrest for DUI/Alcohol. He was the individual with the open container in the vehicle.

The third DUI contact once again involved Deputy Gifford. The male subject who was driving had a female passenger. It should be noted that although I did not observe too much of the field sobriety tests, I did come within close contact with this individual. I observed him on the Walk and Turn test stop at the turn, then stumble on the turn raising his hands. He was ultimately placed under arrest for DUI/Alcohol.

At the conclusion of the sobriety checkpoint, units were advised to conduct liquor license complaint inspections as well as saturation control throughout the metropolitan districts. I completed a Force Commander Summary for this incident.

This concludes my involvement in this case.
